AMENDMENT TO REAL ESTATE CONTRACT

IT IS AGREED this 3 4 day of MARCH, 1997, by and between AgAmerica, FCB, successor in interest to Farm Credit Bank of Omaha, Seller; and Wayne E. Speer and LaDonna K. Speer, husband and wife, of the County of Madison, State of Iowa, Buyers:

- This Agreement relates to and amends a contract of sale between Seller and Buyers, which contract is dated March 29, 1989 and was filed March 29, 1989, at Book 125, Page 427 in the records of the Recorder of Madison County, Iowa,
- Paragraph 1 of said contract shall be amended to change the repayment terms of the contract as follows:

Failure to provide these documents annually may be considered an act of default, or at Seller's option, may result in interest being charged on the entire unmatured balance at the default rate without declaring the contract in default.
- 4. Except as modified by this Agreement, all of the terms, conditions, covenants and warranties of the contract are confirmed and ratified, and remain in full force and effect.
