This agreement provides a service program that will help insure continuous trouble free operation of your sewage treatment plant. Please note that your county does require all aerobic waste water systems to have a maintenance agreement on file with the county as per chapter 69.8, 1, D of the Iowa Code. As with any mechanical device your sewage treatment plant requires periodic servicing to prevent major operational difficulties.

Residential Service Contract

We, Central Iowa Multi-Flo, being an authorized Multi-Flo Service Distributor offer a full service program. Helping to keep your unit functioning properly and spot major trouble before it starts.

This service consists of the following:

1. On site inspections and testing as required by your county.
 - a. Pull test samples of the effluent and have tested for BOD quality. Two times per year as required in Chapter 69.9, 1, of the Iowa Code.
 - b. Results will be mailed to homeowner and respective Health Department.
2. All components are checked, cleaned, repaired or replaced as needed.
3. Filters checked for plugging. Filters will be cleaned or flushed as needed.
4. Multi-Flo checked for level of solids.
 - a. Any pumping of Multi-Flo will be charged (with prior notice and approval) to customer.
5. All labor and material is included to perform all of the above.
6. This plant shall be capable of treating 400 gallons per day of sanitary sewage waste with a 5-day BOD not to exceed 240 PPM.
7. Contract is voided if not used according to the owner's manual.

Note: This service contract is provided at no charge to the customer for two years from the date the unit is started.
