EXHIBIT "A"

A part of the former right-of-way of the Chicago, Burlington and Quincy Railroad Company located in the Southeast Quarter of the Northeast Quarter of Section 23, Township 75 North, Range 26 West of the 5th P.M., City of St. Charles, Madison County, Iowa, more precisely described as follows: Beginning at the Southwest Corner of Lot 12, Kephart's Addition to St. Charles, Iowa, Plat No. 1; thence North 90°00'00" West 66.54 feet along the North line of Clanton Street extended to the Westerly right-of-way line of the former Chicago, Burlington and Quincy Railroad Company; thence Southwesterly along a 767.30 feet radius curve concave Southwesterly 296.69 feet with a 294.95 feet chord bearing South 27°34'06" West; thence Southwesterly along a 1502.84 feet radius curve concave Southeasterly 136.45 feet with a 136.42 feet chord bearing South 11°33'38" West; thence South 89°57'12" East 50.91 feet to the Easterly right-of-way of the former Chicago Burlington and Quincy Railroad Company which is also the Westerly line of Kephart's Addition to St. Charles, Iowa Plat No. 2; thence Northeasterly 124.12 feet along a 1452.84 feet radius curve concave Southeasterly with a 124.08 feet chord bearing North 11°37'05" East; thence Northeasterly 316.77 feet along a 717.30 feet radius curve concave Southeasterly with a 314.20 feet chord bearing North 29°26'43" East to the Point of Beginning. Said Parcel contains 0.504 acres.

The above-described real property is the same real property described as Parcel J in a Plat of Survey for David Lathrum in the Southeast Quarter (1/4) of the Northeast Quarter (1/4) of Section 23, recorded on June 19, 1997, in Town Plat 2, commencing on page 319 in the office of the Madison County, Iowa, Recorder.

Reserving unto Grantor, City of St. Charles, Iowa, a perpetual Easement for the purpose of erecting, constructing, installing, laying and thereafter using, operating, inspecting, repairing, maintaining, replacing and removing waterlines and appurtenances thereto over and across a portion of the above described real estate described as follows:

An Easement 20 feet in width running East and West across the above described real estate commencing at the West termination point of Clanton Street and running thence West to the West property line of the above described real estate, together with the right of ingress and egress over the adjacent lands of Grantors, their successors and assigns for the purpose of this Easement.

This Easement shall be 20 feet in width, the centerline of which shall be the water pipeline and the necessary appurtenances thereto, together with an adjacent temporary construction Easement 10 feet in width for construction purposes.

The City of St. Charles, its successors and assigns hereby promise to maintain such water pipeline and other necessary appurtenances in good repair, so that damage to adjacent real estate of David Lee Lathrum and Martha Ann Lathrum, if any damage there be, will be kept to a minimum.

The Reservation and other provisions of this Easement shall constitute a covenant running with the land for the benefit of the City of St. Charles, Iowa, its successors and assigns.
