Be it remembered that the jury on January 22, 1991, ascertained the damages in Law #23212 to be \$39,000 and in Law #23213 to be \$27,000. This exceeded the condemnation awards made March 9, 1990 of \$33,790 and \$24,875.00 by \$5,210.00 and \$2,125.00 respectively. Be it also remembered that the condemnation awards were released to the defendants by order of this court dated May 14, 1990.

Interest at 10% per annum is payable by the plaintiff to defendants on unpaid sums from the date of possession, stipulated by the parties to have been April 17, 1990. Therefore interest on the entire amounts is due the defendants for the 27 days from April 17 - May 14. Those interest amounts are \$288.49 and \$199.73 respectively. Interest on \$5,210 and \$2,125.00 from May 14, 1990, until paid shall also be paid by the plaintiff to the defendants.

Pursuant to Iowa Code § 472.33 the condemnor is liable to the condemnee for its reasonable attorney's fee if the jury's award exceeds that of the compensation commission. The parties have stipulated that \$4,300.00 is the reasonable attorney's fee and expenses to be awarded in each of the two cases to the defendants. Those sums are ordered payed by plaintiff to defendants.

Court costs are taxed to the plaintiff. Pursuant to Iowa Code \$ 622.72 the clerk shall add \$150.00 to the witness fee of Appraiser Currier and \$75.00 each to the fee of witnesses Garry Kiernan and Carl Henry.

It is so ordered.
