- 4. SPECIAL ASSESSMENTS. Sellers shall pay the special assessments against this property: (Strike out either (a) or (b) below
- (a) Which, if not paid, in the year 19 ______, would become definquent and all assessments payable prior thereto

(c) including all sewage disposal assessments for overage charge heretofore assessed by any municipality heving jurisdiction as of data of possession.

Buyers, except as above stated, shall pay all subsequent special assessments and charges, before they become delinquent

5. MORTGAGE. Any mortgage or encumbrance of a similar nature against the said property shall be timely paid by Sellers so as not to prejudice the Buyers' equity herein. Should Sellers tail to pay, Buyers may pay any such sums in default and shall receive credit on this contract for such sums so paid. MORTGAGE BY SELLERS Sellers, their successors in interest or assigns grey, and hereby reserve the right to at any time mortgage their right, the or interest in such premises or to renew or extend any existing mortgage for any amount not exceeding requirements of this contract. Buyers hereby expressly consent to such a mortgage which shall be prior and persenount to any of Buyers' then rights in seid property. DEED FOR BUYERS SUBJECT TO MORTGAGE. If Buyers have reduced the balance of this contract to the amount of any existing mortgage betance on said premises, they may at their option, assume and agree to pay said mortgage according to its terms, and subject to such mortgage shall receive a deed to said premises; or Sellers, at their option, any time before Buyers have made such a mortgage commitment, may reduce or pay off such mortgage. ALLOCATED Buyers, in the event of acquiring this property from an equity holder instead of a holder of the fee title, or in the event of a mortgage against said premises, reserve the right, if reasonably hereafter options to divide or allocate the payments to the interested parties as their interests may appear. SELLERS AS TRUSTEES. Sellers agree that they will collect on money hereunder in excess of the amount of the unquid belance under the terms of this contract less the total amount of the encumbrance on the interest of Sellers in their assigns in said real negative of the Buyers for the use and benefit of the Buyers.

8. INSURANCE. Except as may be otherwise included in the last sentence of paragraph 1(b) above, Buyers as and from said date of possession, shall constantly keep in force insurance, premiums therefore to be prepaid by Buyers (without notice or demand) against loss by fire, fornace and other hazards, casualties and contingencies as Setter may reasonably require on all buddings and improvements, now on or hereafter placed on said premises and any personal property which may be the subject of this contract, in companies to be reasonably approved by buddings and improvements, now on or hereafter placed on said premises and approperly or not less than the unpaid purchase price herein whichever amount is smaller with sellers in an amount not less than the full insurance payable to Setters and Buyers as their interests may appear. BUYERS SHALL PROMPTLY DEPOSIT SUCH POLICY WITH PROPER RIDERS WITH SELLERS for the further security for the payment of the sums herein mentioned. In the event of any such casualty loss, the insurance proceeds may be used under the supervision of the Setters to replace or repair security for the payment of the sums herein mentioned. In the event of any such casualty loss, the insurance proceeds may be used under the supervision of the Setters to replace or repair the loss if the proceeds be adequate; if not, then some other reasonable application of such lunds shall be made; but in any event such proceeds shall stand as security for the payment of the policy.

7. CARE OF PROPERTY. Buyers shall take good care of this property; shall keep the buildings and other improvements now or hereafter placed on the said premises in good and reasonable repair and shall not injure, destroy or remove the same during the kite of this contract. Buyers shall not make any material alteration in said premises without the written consent of the Setters. Buyers shall not use or permit said premises to be used for any ideal purpose.

- 8. LIENS. No mechanics' lien shall be imposed upon or foreclosed against the real estate described herein
- 9. ADVANCEMENT BY SELLERS. It Buyers fall to pay such laxes, special assessments and insurance and effect necessary repairs, as above agreed, Sellers may, but need not, pay such taxes, special assessments, insurance and make necessary repairs, and all sums so advanced shall be due and payable on demand or such sums so advanced may, at the election of Sellers, be added to the principal amount due hereunder and so secured. (For Buyers' rights to make advancements, see paragraph 5 above.)
- 10, JOINT TENANCY IN PROCEEDS AND SECURITY RIGHTS IN REAL ESTATE. If and only if, the Setters immediately preceding this sale, hold the title to the above described property in joint tenancy, and such joint tenancy has not later been destroyed by operation of law or by acts of the Setters, this sale shall not constitute such destruction and the proceeds of this contract, and any continuing and/or receptured rights of Setters in said rest estate, shall be and continue in Setters as joint tenants with rights of survivorship and not as tenants in common; and Buyers, in the event of the death of one of such joint tenants, agree to pay any balance of the proceeds of this contract to the surviving Setter (or Setters) and to accept deed solely from him or them consistent with paragraph 14 below unless and except this paragraph is stricken from this agreement.
- 11. SELLERS. Spouse, if not titleholder immediately preceding this sale, shall be presumed to have executed this instrument only for the purpose of relinquishing all rights of dower, homestead and distributive share and/or in compliance with section 561.13 Code of lower; and the use of the word "Sellers" in the printed portion of this contract, without more, shall not rebut such presumption, nor in any way enlarge or extend the previous interest of such spouse in said property, or in the sale proceeds, nor bind such spouse except as aforesaid, to the terms
- 12. TIME IS OF THE ESSENCE. Time is of the essence in this Agreement. Failure to promptly essent rights of Sellers herein shall not, however, be a waiver of such rights or a waiver of any existing or subsequent default.
