WARRANTY DEED

For the consideration of Eighty and no/100----(\$80.00)----DOLLARS and other valuable consideration in hand paid by Iowa Department of Transportation, Clere Weaver, single, does hereby convey to the STATE OF IOWA real estate in Madison County, Iowa:

THE FEE SIMPLE TITLE GRANTED IS TO LAND DESCRIBED AS FOLLOWS:

A parcel of land located in the NE¼ SW¼ of Section 29, T76N, R26W of the 5th P.M., Madison County, Iowa, as shown on Acquisition Plat Exhibit "A" attached hereto and by reference made a part hereof, and more particularly described as follows:

Commencing at the NW Corner of the NE¼ SW¼ of said Section 29; thence S1°41'11" E 313.50 feet along the west line of the NE¼ SW¼ of said Section 29, to a point on the present southwesterly right of way line of Primary Road No. Ia. 92; thence N89°24'21" E 106.26 feet along said present southwesterly right of way line, to the Point of Beginning; thence continuing N89°24'21" E 149.16 feet; thence S1°54'34" E 85.18 feet; thence northwesterly 173.56 feet along a 1470.89 ft. radius curve, concave southwesterly and having a chord bearing N61°11'37" W 173.46 feet, to a point on the present southwesterly right of way line of Primary Road No. Ia. 92, the Point of Beginning, containing 0.14 acre, of which 0.10 acre is contained within present highway easements.
