EASEMENT FOR PUBLIC HIGHWAY

Know All Men By These Presents: That Thomas Harger also known as Thomas R. Harger and Barbara A. Harger, husband and wife, of Madison County, State of Iowa, in consideration of the sum of Two Thousand Nine Hundred and Fifteen and no/100----(\$2,915.00)----DOLLARS and other valuable considerations in hand paid by Iowa Department of Transportation, do hereby grant an easement unto the STATE OF IOWA, for road purposes and for use as a Public Highway, the following described premises situated in the County of Madison, State of Iowa, to-wit:

A parcel of land located in the SW 1/4 SW 1/4, the NW 1/4 SW 1/4, and the NE 1/4 SW 1/4, all of Sec. 26, T76N, R27W of the 5th P.M., Madison County, Iowa, as shown on Acquisition Plat Exhibit "A" attached hereto and by reference made a part hereof.

THE EASEMENT RIGHT, FOR HIGHWAY PURPOSES, GRANTED IS TO LAND DESCRIBED AS FOLLOWS:

Commencing at the SW Corner of said Sec. 26; thence N2°05'49"W, 1097.68 ft. along the west line of the SW 1/4 of said Sec. 26 to the Point of Beginning; thence continuing N2°05'49"W, 207.94 ft. along said west line to a point on the present southerly right of way line of Primary Road No. Ia. 92; thence northeasterly 147.90 ft. along said present southerly right of way line, along a 1399.39 foot radius curve, concave southerly and having a chord bearing N69°13'00"E, 147.90 ft.; thence N72°14'45"E, 1486.42 ft. along said present southerly right of way line; thence S1°01'18"W, 81.12 ft.; thence S72°06'09"W, 77.06 ft.; thence S72°14'45"W, 386.08 ft.; thence S45°40'51"W, 111.80 ft.; thence S72°14'45"W, 112.00 ft.; thence N35°52'34"W, 57.87 ft.; thence S72°14'45"W, 520.00 ft.; thence S31°34'15"W, 84.39 ft.; thence S74°30'23"W, 302.95 ft.; thence S24°25'39"W, 125.50 ft. to a point on the west line of the SW 1/4 of said Sec. 26, the Point of Beginning; excepting therefrom present easements of records; containing 3.46 acres, exclusive of said exceptions.




