WHEREAS, there was filed in the office of the Zoning Administrator of the City of Winterset a registered land surveyor's plat of a proposed subdivision known as the Lanny Wenck Addition; and

WHEREAS, the Final Subdivision Plat was accompanied by various documents including a Dedication of Plat. This Dedication erroneously indicated the real estate being platted was owned by Lanny Wenck, individually, when in truth and in fact this real estate was owned by Lanny's Auto Company, an Iowa Corporation doing business in Madison County, Iowa, with Lanny Wenck the President of the Corporation.

WHEREAS, the original Resolution Approving Final Plat indicated Lanny Wenck, individually, was the proprietor of the real estate to be dedicated for platting. This resolution corrects and supersedes this prior Resolution to indicate the owner of the dedicated real estate as Lanny's Auto Company; and

WHEREAS, the real estate comprising said plat if described as follows:

- 1. This Resolution corrects and supersedes the prior Resolution approving the Final Plat of the Lanny Wenck Addition to the City of Winterset, Iowa.
- 2. That said Plat, is known as Lanny Wenck Addition, prepared in connection with said Plat and subdivision is hereby approved.
- 3. The Zoning Administrator of the City of Winterset, Iowa, is hereby directed to certify this Resolution which shall be affixed to said Plat to the County Recorder of Madison County, Iowa, and attend to the filing and recording of the Plat, papers and documents which should be filed and recorded in connection therewith.
