

EASEMENT

For valuable consideration, Bruce Bellamy and Georgine Bellamy, husband and wife, Gregory L. Bellamy, single, and Ivan Pryor and Darlene Pryor, husband and wife, hereby grant to the Worthington Methodist Church a perpetual easement over and across the following-described real estate:

The South 60 feet of the West 1125 feet of the Northwest Quarter (NW 1/4) of the Northwest Quarter (NW 1/4) of Section Thirty-three (33), Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, except the West 165 feet thereof,

for the purpose of construction, maintenance and repair of the well and water line to supply water to the church building and residence owned by the church located west of the above-described tract, together with the right of ingress and egress to and from said easement area for the purpose of repairing and maintaining said well and water line.

The water from the well shall be used solely for residential household purposes and for use at the church building by members of the congregation, and shall not be used for farm purposes or any other commercial purposes. In the event Grantors' crops are damaged by the construction, maintenance or repair of such well or water line, Grantee shall pay Grantors damages for such crop damages.
