AGREEMENT FOR MODIFICATION OF PIPELINE EASEMENT

THIS AGREEMENT made and entered into this 18th day of June, 1963, by and between MERRITT BAUR and MARY BAUR, husband and wife; R. EDWARD BAUR and LORRAINE BAUR, husband and wife; and RYMAN J. SMITH and MERIAM A. SMITH, husband and wife, parties of the first part hereinafter referred to as GRANTORS, and NORTHERN GAS PRODUCTS COMPANY, hereinafter referred to as GRANTEE, WITNESSETH:

WHEREAS, the Grantors herein have heretofore granted the Grantee an easement over and across the following described real estate located in Madison County, Iowa, to-wit:

The East One Hundred Ten (110) Acres of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Twenty-three (23), Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M.,

which easement is dated January 30, 1963, and,

WHEREAS, the Grantee is desirous of changing the location of the pipeline to be constructed across said premises.

NOW THEREFORE in consideration of the sum of Three Hundred and no/100 Dollars (\$300.00) in hand paid to the Grantors by the Grantee herein, the parties hereto agree that the pipeline to be constructed across said premises shall enter the property at a point approximately 638 feet south of the north line of said northwest quarter and shall run in a northeasterly direction to a point approximately 360 feet south of the northeast corner of said northwest quarter.

It is agreed between the parties hereto that the above described location of said pipeline shall be in lieu of the location described in said easement dated January 30, 1963, and the Grantee herein by

the acceptance and recording of this agreement hereby waives, abandons and relinquishes any right or claim to construct a pipeline at the location described in said original easement.

It is agreed between the parties hereto that except as herein modified as to the location of said pipeline, all the terms and conditions of said original pipeline easement and any supplements thereto are hereby ratified and confirmed.
