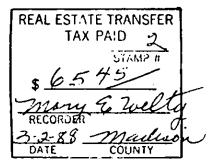

The North 92.5 acres of the West Half (W 1/2) of the East Half (E 1/2) of Section Thirty-five (35), Township Seventy-six (76) North, Range Twenty-seven (27) of the 5th P.M., except a strip of land 231 feet wide all along the north end of this tract, which is 231 feet by 1320 feet being a 7 acre parcel of land. Also except a parcel of land running East and West 800 feet and North and South 275 feet located in the very Southeast corner of the above described 92.5 acres.
