QUITCLAIM DEED
TO MADISON COUNTY, IOWA

The Iowa Department of Transportation, by Darrel Rensink, Director, acting for the State of Iowa by authority of Section 306.42, The Code, hereby quitclaims, grants and conveys unto Madison County, Iowa, all rights, easements, title and interest in all land used as street and highway right of way, all roadway, and all right of way and roadway appurtenances thereto, together with any other lands and interests in land which may have been acquired by prescription and by adverse possession and by any other title instrument and by the public's use thereof as a public roadway, and any bridges, culverts or structures that may be situated thereon, to the following described roadway situated in Madison County, Iowa, to-wit:

That portion of former Primary Road No. 92, which is now a part of the local secondary road system, beginning at Sta. 2719+30, said Station being 299.9 ft. east of the N 1/4 Corner of Sec. 2-75-28; thence easterly to the NW Corner of Sec. 1-75-28; thence continuing easterly to the West Corporation Line of the City of Winterset, Madison County, said corporation line being 811.14 ft. west of the N 1/4 Corner of Sec. 1-75-28, excepting therefrom all that part located in Sec. 36-76-28, said part being in the corporation limits of the City of Winterset, all a distance of approximately 0.86 mile.

Title and interest to part of the above described roadway was acquired by the State of Iowa through the following title instrument(s) filed and recorded in the records of Madison County, Iowa.

This transaction is exempt from Chapter 428A, because the State of Iowa is the Grantor, pursuant to Section 428A.2(6) of the Code.


