The South 250 feet of the North 380 feet of the following-described real estate:


That part of the Southwest Quarter (1/4) of the Southeast Quarter (1/4) and the Southeast Quarter (1/4) of the Southwest Quarter (1/4) of Section 15; the Northwest Quarter (1/4) of the Northeast Quarter (1/4) and the Northeast Quarter (1/4) of the Northwest Quarter (1/4)of Section 22, all in Township 75 North, Range 26 West of the 5th P.M., bounded and described as follows: Commencing at a point on the North line of Orchard Street, distant 150 feet Southeasterly, measured radially, from the center line of the main track (now removed) of the Chicago, St. Paul and Kansas City Railway Company (later the Chicago Great Western Railway Company, now the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Section 22; thence Northeasterly parallel with said original main track center line a distance of 60 feet to the point of beginning of the parcel of land herein described; thence Westerly parallel with the Westerly extension of the North line of Orchard Street a distance of 110 feet, more or less, to a point distant 50 feet Southeasterly, measured radially, from the center line of the main track (now removed) of the Chicago and North Western Transportation Company (formerly the Chicago Great Western Railway Company), as said main track was located prior to its removal; thence Southwesterly parallel with said last described main track center line a distance of 100 feet; thence Westerly parallel with the Westerly extension of the North line of Orchard Street a distance of 225 feet, more or less, to a point distant 150 feet Northwesterly, measured radially, from said original main track center line; thence Northeasterly parallel with said original main track center line a distance of 1,151 feet, more or less, to a point on the center line of a public road running Northwesterly and Southeasterly through said Southwest Quarter (1/4) of the Southeast Quarter (1/4) of Section 15; thence Southeasterly along the center line of said public road a distance of 318 feet, more or less, to a point distant 150 feet Southeasterly, measured at right angles, from the center line of said original main track; Southwesterly parallel with said original main track center line a distance of 970 feet, more or less, to the point of beginning.
