EASEMENT FOR PUBLIC HIGHWAY

Know All Men By These Presents: That Harriet I. Campbell, single, holder of a Life Estate, of Madison County, State of Iowa; Madison County Memorial Hospital Association (also known as Madison County Memorial Hospital), having its principal place of business at Winterset, in Madison County, State of Iowa, a corporation organized and existing under the laws of the State of Iowa, in consideration of the sum of Four Thousand Five Hundred Eighty-four and no/100 -----(\$4,584.00)-----DOLLARS and other valuable considerations in hand paid by Iowa Department of Transportation, do hereby sell and convey unto the STATE OF IOWA, for road purposes and for use as a Public Highway, the following described premises situated in the County of Madison, State of Iowa, to-wit:

Two parcels of land located in the SW 1/4 SW 1/4 of Sec. 19, T76N, R27W of the 5th P.M., and in the SE 1/4 NE 1/4 of Sec. 24, T76N, R28W of the 5th P.M., all in Madison County, Iowa, as shown on Right of Way Plats 1 of 2 and 2 of 2 Exhibit "A" attached hereto and by reference made a part hereof.

THE EASEMENT RIGHT, FOR HIGHWAY PURPOSES, GRANTED IS TO LAND DESCRIBED AS FOLLOWS:

Plat 1 of 2: Beginning at the SW Corner of said Sec. 19; thence N0°00'25"W, 1327.00 ft. along the west line of the SW 1/4 of said Sec. 19 to a point on the north line of the SW 1/4 SW 1/4 of said Sec. 19; thence S89°21'59"E, 157.04 ft. along said north line; thence S2°22'33"W, 1327.39 ft. to a point on the south line of the SW 1/4 SW 1/4 of said Sec. 19; thence N89°26'56"W, 101.84 ft. along said south line to the SW Corner of said Sec. 19, the Point of Beginning, excepting therefrom present easements of record; containing 2.41 acres, more or less, exclusive of said exceptions.

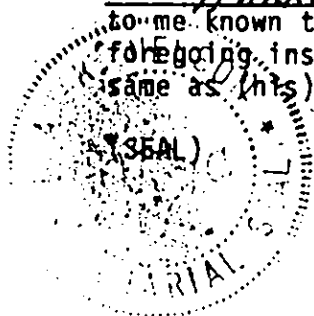

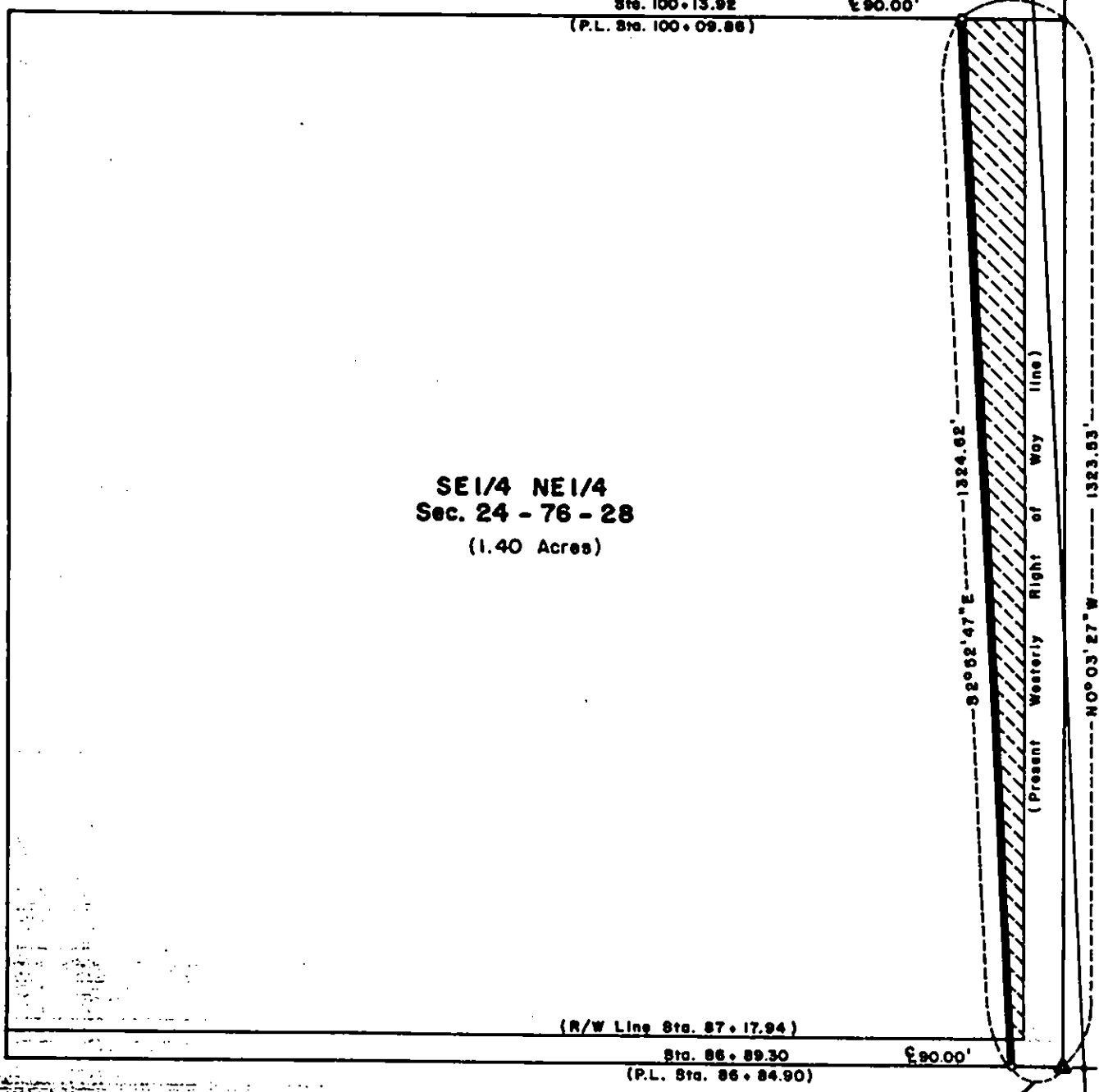

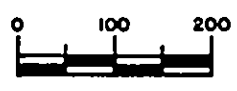
