

AGREEMENT

THIS AGREEMENT made and entered into by and between Madison County, Iowa, and the City of Winterset, Iowa, hereinafter called the City, in accordance with the provisions of Chapter 28E, 1989 Code of Iowa.

IT IS AGREED as follows:

1. The previous agreement dated March 3, 1986 is made void.
2. Madison County shall perform road and street maintenance on or within the Corporate limits of the City as follows:

- a. Blading granular surfaced streets
- b. Granular resurfacing
- c. Snow removal
- d. Portland Cement Concrete Pavement patching
- e. Mowing shoulders
- f. Pavement markings and signs

All other construction and maintenance work shall be considered on a project by project basis and shall not be a part of this agreement.

The City shall reimburse Madison County for the following:

- a. One half material and haul cost for granular resurfacing (Corporate line roads only).
  - b. Actual cost of materials for signs and actual cost for pavement markings.
3. Road and Street maintenance shall be performed by the City or County on certain streets as shown on the attached City map which shall become a part of this agreement. Revisions to the map may be made from time to time by letter of agreement between the Administrator and the City Administrator.
  4. Madison County shall provide the City with current equipment rental rates and labor rates in July of each year for use until June 30 of the following year. Madison County shall provide the City with materials and haul invoices for each individual maintenance project.

- 5. Madison County shall bill the City for costs due on a quarterly basis. Additional billings for specific projects may be arranged jointly by the City and Madison County.
- 6. This agreement may be terminated by either party upon written notice at least 180 days prior to June 30, each year, and upon settlement of all unpaid costs. If such written notice is not received by either party, this agreement shall continue for the succeeding year.
- 7. The County Engineer shall administer this agreement as provided in Section 28E.6 of the 1989 Code of Iowa. The County Engineer shall consult with the Board of Supervisors and the City Administrator on matters related to this agreement. No real and/or personal property will be acquired under the provisions of this agreement.
- 8. This agreement shall not prohibit the Administrator from hiring a private contractor to perform work associated with this agreement.
