

SPECIAL WARRANTY DEED

S. 1464(d)(2).

FOR VALUE RECEIVED, the Resolution Trust Corporation, as Conservator of United Federal Savings Association of Iowa, Des Moines, Iowa, having a mailing address of Locust at 4th Street, Des Moines, Iowa 50309 ("Grantor"), does hereby sell and convey unto North American Savings Bank ("Grantee"), having a mailing address of 125th & South 71 Highway, Grandview, MO 64030, and unto the Grantee's successors and assigns, the real estate ~~more particularly described on Exhibit "A", which is attached hereto and by this reference~~ incorporated herein.

TO HAVE AND TO HOLD THE SAME, together with all and singular the rights, privileges, appurtenances and immunities thereunto belonging or in any wise appertaining, forever. The Grantor hereby covenants that the premises are free and clear from any encumbrance done or suffered by it except for easements, restrictions, covenants and encumbrances of record; and that it will warrant and defend the title to the premises unto the Grantee and unto the Grantee's successors and assigns against the lawful claims and demands of all persons claiming under the Grantor as a result of any such encumbrance, but none other.
