

Parcel "K" (North & South) are currently owned by Lonna J. Nielsen. Parcel "L" is currently owned by Jack E. & Maria J. Brown.


## LEGAL DESCRIPTION:

Parcel "K" in the Northeast Quarter of the Southwest Quarter of Section 13, Township 76 North, Range 29 West of the 5<sup>th</sup> P.M., Madison County, Iowa is made up of two separate parcels more particularly described as Parcel "K" (North) and Parcel "K" (South):

## Parcel "K" (North)

Commencing at the Center of Section 13, Township 76 North, Range 29 West of the 5<sup>th</sup> P.M., Madison County, Iowa thence South 89°45'50" West 399.50 feet along the North line of the Northeast Quarter of the Southwest Quarter of said Section 13 to the Point of Beginning; thence South 00°47'58" East 910.79 feet along the existing fence line; thence North 03°'41'22" West 912.40 feet to a point on the North line of said Northeast Quarter of the Southwest Quarter, which is 445.50 feet (27 rod) West of the Center of said Section 13; thence South 89°45'50" West 46.00 feet to the Point of Beginning containing 0.48 acres.
