The South Half (½) of the Northeast Quarter (¼) of Section Twenty (20), and the South Half (½) of the Northwest Quarter (¼) of Section Twenty-one (21), all in Township Seventy-seven (77) North, Range Twenty-six (26) West of the 5<sup>th</sup> P.M., Madison County, more particularly described as follows:

Beginning at a iron pin found at the Northwest Corner of said South Half ( $\frac{1}{2}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Twenty (20);

thence North 83°22'14" East a distance of 2664.56' to an iron pin; thence North 83°54'16" East a distance of 2626.38' to an iron pin; thence South 00°20'22" East a distance of 1327.14' to an iron pin; thence South 83°56'58" West a distance of 2649.74' to an iron pin; thence South 83°23'27" West a distance of 2653.40' to an iron pin; thence North 00°11'58" East a distance of 1325.30' to the Point of Beginning;

Containing 160.264 acres of land including 1.215 acres of Madison County road right of way.
