## TRUSTEE WARRANTY DEED

For the consideration of One Dollar(s) and other valuable consideration, THE MICHAEL P. BURGUS TRUST SHARE OF THE BURGUS FAMILY TRUST, <u>Jay N. Lakritz</u>, <u>AVP</u>, and <u>Pamela Benson</u>, <u>VP</u>, Trustees, hereby convey to ARTHUR N. JOURA, ROBERTA JOURA, and GREGORY ARTHUR JOURA, as Joint Tenants with Full Rights of Survivorship and not as Tenants in Common, the following described real estate in Madison County, Iowa:

Units numbered 1, 2, 3, 4, 5, and 6 of JEFFERSON STREET APARTMENTS in the City of Winterset, Madison County, Iowa, each unit having an undivided 1/6 interest in the common elements of JEFFERSON STREET APARTMENTS, located in the North Half (N 1/2) of Lot 1 and the East One-Third (E 1/3) of the North One-Half (N 1/2) of Lot Two (2) in Block Seventeen (17) of the Original Town of Winterset, Madison County, Iowa.
