Addendum

1. A parcel of land located in the NWFrl. ¼ of Section 5, Township 77 North, Range 29 West of the 5th P.M., Madison County, Iowa lying on the Southeasterly side of part of the following described centerline of Interstate Route No. 80 as shown on official plans for Project I-IG-80-2(6)96. The centerline, designated by station points 100 feet apart, numbered consecutively from Southwest to Northeast, is described as follows: Beginning at Station 1449+06.7, a point 1284.9 feet West of the Northeast corner of said Section 5, on the North line thereof, thence S43°11½ West 3502.2 feet to Station 1414+04.5. Said parcel is described as follows: All that part of said NWFrl.¼ that lies Southeasterly of a line 150 feet normally distant Southeasterly from and parallel to the above described centerline, said parcel contains 8 acres, more or less.
