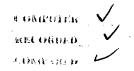
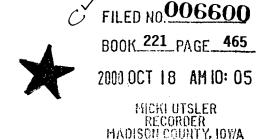

AGREEMENT TO EXTEND MORTGAGE AND MODIFICATION AGREEMENT

AGREEMENT made this 15th day of September ,2000, between Timothy A. Sears and Carrie Bozis Sears residing at 3375 138th Lane, Cumming, Ia., hereinafter referred to as Mortgagor(s), and First Bank, a corporation organized and existing under the laws of the State of Iowa having its principal place of business at 1630 - 22nd Street, West Des Moines, Iowa 50265, hereinafter referred to as Mortgagee.

WHEREAS, the Mortgagor(s) executed a certain Promissory Note dated the 9th day of August, 1999, whereby (s) he/they promised to pay to Mortgagee the sum of One Hundred Thousand and 00 /100 on the 9th day of June, 2000, with interest thereon at the rate of 8.50 percent per annum; and

WHEREAS, the said note is secured by certain mortgage, dated the 9th day of August, 1999 and recorded on the 10th day of August, 1999, in the Office of the Recorder of Madison County, Iowa, in Book 211, pages 265; and

WHEREAS, the Mortgagee is now the holder of said note and mortgages; and the Mortgagor(s) is the owner of the mortgaged premises.

NOW, THEREFORE, the parties hereto mutually agree that the time of payment of One hundred Thousand and 00/100's Dollars (\$100,000), the aggregate principal sum presently remaining unpaid, shall be and hereby is extended and the said principal shall be due and payable as hereinafter set forth, with interest thereon, on the unpaid balances thereof as hereinafter set forth.

That the principal sum is, and the same is, hereby extended for a term of sixty (60) months from the 15th day of September, 2000, and the said principal sum shall bear interest from that date at the rate of 8.00 percent per annum.

Principal and interest payments due on the 15th of October and monthly thereafter on the 15 of each month. It is expressly understood and agreed that the said mortgage shall remain in full force and effect in all respects as if the said principal sum had originally been payable on the 9th day of June, 1999, and that nothing herein shall affect or impair any rights and powers which the Mortgagee may have thereunder for the recovery of the mortgaged debt, with interest, in case of the nonfulfillment of this Agreement.

And the Mortgagors(s) hereby agrees that (s) he/they will pay the said principal sum on the 15th day of September, 2005, and the interest therein at the times herein before specified, and (s) he/they will perform and observe all the covenants, agreements, stipulations, and conditions on the part of the Mortgagor(s) in said mortgage contained in all respects as if the said principal sum had by the terms thereof been payable on the last mentioned date.

This agreement shall be binding upon the successors, heirs, administrators, and assigns of the respective parties hereto.
