ORDINANCE NO. 1859

AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF WEST DES MOINES, IOWA, 2009, BY AMENDING TITLE 9, ZONING, AND TITLE 10, SUBDIVISION REGULATIONS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST DES MOINES, IOWA:

Section 1. Amendment. Title 9, Zoning is hereby amended by replacing all references to the "Community Development Department", "Department of Community Development", or any other variation of the same with "Department of Development Services".

Section 2. <u>Amendment.</u> Title 9, *Zoning* is hereby amended by replacing all references to the "Director of Community Development", "Community Development Director", or any other variation of the same with "Director of Development Services".

Section 3. <u>Amendment.</u> Title 9, Zoning, Chapter 3, General Zoning Provisions, Section 7, Yards,, Subsection C, Required Yard Cannot Be Reduced is hereby amended by removing the strikethrough language below and replacing it with the language in bold:

C. Required Yard Cannot Be Reduced: No lot shall be reduced in size so as to make the width or total area of the lot, or any yard, or any other open space, less than the minimum required by this Title. No part of a yard or other open space provided about any building or structure for the purpose of complying with the provisions of this Title shall be included as a part of a yard or other open space required under this Title for another building or structure. Off-street parking and loading areas may occupy all or part of any required yard or open space except as specified in Section 9-3-9 9-19-8-I of this Chapter Title.

Section 4. <u>Amendment.</u> Title 10, Subdivision Regulations, Chapter 3, Design Standards, Section 1, Subdivision Design Standards, Subsection B, Blocks is hereby amended by removing the strikethrough language below and replacing it with the language in bold:

B. Blocks: Blocks shall conform to the following requirements:

Length: No block shall be longer than one thousand three hundred twenty feet (1,320'), except as otherwise approved by the Commission and Council. (In EU-1 Residential Estate (RE) zoned area, maximum block length shall be 2,006'.)

Section 5. Repealer. All ordinances or parts of ordinances in conflict with the provision of this ordinance are hereby repealed.

Section 6. <u>Savings Clause</u>. If any section, provision, sentences, clause, phrase or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentences, clause, phrase or part hereof not adjudged invalid or unconstitutional.

Section 7. <u>Violations and Penalties</u>. Any person who violates the provisions of this Ordinance upon conviction shall be punished as set forth in Section 1-4-1 of the City Code of the City of West Des Moines, Iowa.

Section 8. Other Remedies. In addition to the provisions set out in the Violations and Penalties Section herein, the City may proceed in law or equity against any person, firm or corporation for violation of any section or subsection of this Ordinance.

Section 9. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
