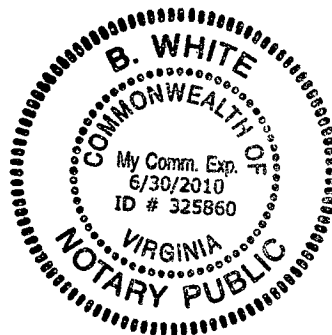


Dear Mr. Hanson:
