

Description — Parcel E

That part of Parcel C located in the Northeast Quarter of the Southeast Quarter of Section 24, as recorded in Book 2001, Page 4525, and of the Southeast Quarter of the Southeast Quarter of Section 24, all in Township 76 North, Range 26 West of the Fifth Principal Meridian, Madison County, lowa, described as follows:

Beginning at the southwest corner of the Southeast Quarter of the Southeast Quarter of said Section 24; thence on an assumed bearing of North 82 degrees 39 minutes 02 seconds East 150.00 feet along the south line of said Southeast Quarter of the Southeast Quarter; thence North 00 degrees 15 minutes 58 seconds West 1,332.66 feet to the north line of said Southeast Quarter of the Southeast Quarter, also being the south line of said Parcel C; thence North 00 degrees 15 minutes 58 seconds West 66.84 feet to an existing fence line; thence South 83 degrees 43 minutes 07 seconds West 149.67 feet along said fence line to the west line of the Northeast Quarter of the Southeast Quarter of said Section 24, also being the west line of said Parcel C; thence South 00 degrees 15 minutes 41 seconds East 70.16 feet along said west lines to the northwest corner of the Southeast Quarter of the Southeast Quarter, also being the southwest corner of said Parcel C; thence South 00 degrees 15 minutes 58 seconds East 1,332.15 feet to the southwest corner of the Southeast Quarter of the Southeast Quarter of said Section 24 and the point of beginning.

Said tract contains 4.79 acres and is subject to a Madison County Highway Easement over the southerly 0.14 acres thereof.
