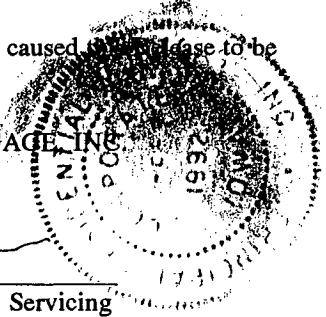
IOWA RELEASE AND SATISFACTION OF MORTGAGE

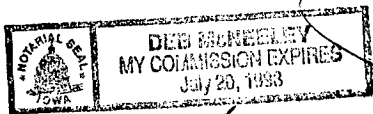
