Upon the final fulfillment of their Agreement according to its terms, the parties or their respective successors and assigns, shall prepare, file and record with the Madison County Recorder's Office an agreement signed by the parties or their respective successors and assigns acknowledging the fulfillment of the terms and conditions of the Agreement, dated December, 2009, and otherwise mutually terminating the Agreement as a matter of record.
