AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, L. RICHARD WINKLER AND DIANA F. Whereas, the Borrower has agreed with the Government to extend the time of payment of all or a portion of the Note described on the above mentioned Mortgage.

NOW, THEREFORE, The Borrower hereby agrees to pay the extended portion of the Note in accordance with the terms of the rescheduled or reamortized Promissory Note (s) described as follows:

All covenants and conditions of said Mortgage shall remain in force except as modified by this instrument.
