

INDIVIDUAL TRUSTEE'S AFFIDAVIT

RE: That part of the Southwest Quarter (1/4) of Section Thirty-three (33), Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, described as follows: Beginning at the Southwest corner of said Section Thirty-three (33); thence North 00°00' East (assumed for the purpose of this description only) along the west line of said Southwest Quarter (1/4) (determined by splitting existing right-of-way fences), 1340.06 feet; thence North 89°35' East, 685.24 feet; thence South 00°25' East, 920.0 feet; thence North 89°35' East, 275.0 feet; thence South 00°25' East, '420.0 feet to the south line of said Southwest Quarter (1/4) (determined by splitting existing right-of-way fences); thence South 89°35' West along said south line of the Southwest Quarter (1/4), 970.0 feet to the point of beginning; containing 23.88 acres, more or less, subject to road rights-of-way over the West 33 feet and South 40 feet thereof. Said road rights-of-way containing 1.94 acres, more or less, as fenced.

Davidshofer pursuant to a Deed dated June 3, 1988, and accordingly the above real estate should not have been included in the June 9, 1992 Deed to the Trust.
- 4. The Trust is in existence and I, as trustee, am authorized to transfer the interest in the real estate described above, free and clear of any adverse claims.
- 5. My wife, Hildreth N. Florer is deceased. The Trust dated February 13, 1992 does not owe, and the subject real estate is not subject to, any Iowa inheritance tax or estate tax.
