The affiant further states that on or about July 18, 1994 the City proposed to sell the above described real estate and set the sale proposal for hearing before the City Council on or about August 1, 1994. The City Council upon hearing approved the proposed sale of this real estate to adjoining property owners. However, the adjoining property owners with regard to the above described real estate declined and refused to purchase the real estate.
