Winterset, Madison County, Iowa**



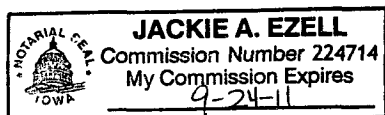


