See Drawing Attached Hereto Showing a 20' strip of land to be used for sewer easement further described as that part of the land located in Northwest Quarter (NW 1/4) of Southwest Quarter (SW 1/4) Section Twenty-four (24), Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., City of St. Charles, Madison County, Iowa.

together with the right of ingress and egress over and across said easement area for the purpose of constructing, installing, laying and thereafter using, operating, inspecting, repairing, maintaining and replacing a sanitary sewer transmission line over, under, across and through said real estate and installation of said line.

The Grantors warrant and covenant to the Grantee that they are the owners of the real estate upon which said easement area is situated, that said real estate is free and clear of liens and encumbrances; and that Grantors have the full right and authority to validly grant this easement, and the Grantee may quietly enjoy its estate in the premises.

Grantors covenant that no act will be permitted within the easement area which is inconsistent with the rights hereby granted; and no buildings or structures will be erected upon said easement area; and, that the present grade or ground level thereof will not be changed by excavation or filling.

This Easement shall run with the land and bind and enure to the benefit of the heirs, successors and assigns of the parties. Grantee shall be solely responsible for the maintenance of the easement area, and Grantors shall have no responsibility therefor.
