

RESOLUTION APPROVING PLAT OF SURVEY

WHEREAS there was filed in the office of the Zoning Administrator of the City of Winterset, Madison County, Iowa, a registered land surveyor's plat of a proposed plat of survey for real estate owned by Agriland FS Inc.; and

WHEREAS the real estate comprising this plat of survey is described as follows: Parcel "N" in the Northwest Quarter of the Southeast Quarter of Section 31, Township 76 North, Range 27 West of the 5th P.M., Madison County, Iowa more particularly described as follows: Commencing at the Center of Section 31, Township 76 North, Range 27 West of the 5th P.M., Madison County, Iowa; thence South 89°54′11" East, 30.00 feet to a point on the East line of TENTH STREET in the City of Winterset; thence along said East line of TENTH STREET, South 00°12′57" East, 150.00 feet to the point of beginning. Thence continuing South 00°12′57" East, 48.00 feet; thence South 89°54′11" East, 110.00 feet; thence North 00°12′57" West, 48.00 feet; thence North 89°54′11" West 110.00 feet to the point of beginning and containing 5,280 square feet.
