AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said J. Dana and Melinda Austin\_hereby agrees to pay on the 29th day of December A.D., 20 00, the principal sum of Fifteen Thousand Thirty-two and 17/100------(\$15,032.17) DOLLARS, remaining unpaid on the said note and mortgage, \$227.57 is to be paid monthly beginning January 2, 2001 and each month thereafter until December 2, 2003 when the unpaid balance is due, with interest from November 28, 2000 at the rate of 9.9 per cent per annum payable monthly beginning on the 2nd day of January, 2001 and each month thereafter, with both principal and interest payable at UNION STATE BANK.
