AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 5th day of June, 1998, Leslie C Bortell, A Single Person executed to UNION STATE BANK, WINTERSET, IOWA a certain note dated on that day for the sum of Twenty-four Thousand and 00/100---(\$24,000.00) DOLLARS, payable on the 5th day of June A.D., 2001, and at the same time the said Leslie C Bortell executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 5th day of June A.D., 1998 at 3:32 o'clock P. M., in Book 199 of Mortgages, on page 253 and,

Whereas, Leslie C Bortell is now the owner of the real estate described in said Mortgage(XX

XX DOLLARS, and,

Whereas, there remains unpaid on the principal of said mortgage the sum of Twenty-two Thousand Four Hundred Sixty-five and 73/100 -----(\$22,465.73) DOLLARS, and,

Whereas, the said maker has agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said Leslie C Bortell hereby agrees to pay on the 14th day of June A.D., 2001, the principal sum of Twenty-two Thousand Four Hundred Sixty-five and 73/100--- (\$22,465.73) DOLLARS, remaining unpaid on the said note and mortgage, \$ 198.58 is to be paid monthly beginning on July 5th, 2001 and each month thereafter until June 5th, 2004 when unpaid balance and accrued interest is due with interest from June 4, 2001 at the rate of 7.750 per cent per annum due monthly, beginning on the 5th day of July, 2001 and each month thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from June 14, 2001 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of _____ per cent per annum.
