AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 23rd day of January, 1984. Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said Charles E. and Ada Sue Tucker hereby agrees to pay on the 3rd day of April A.D., 2001, the principal sum of Four Thousand Three Hundred Fifty-seven and 54/100-----(\$4,357.54) DOLLARS, remaining unpaid on the said note and mortgage, \$559.13 is to be paid in full each year beginning on April 1, 2002 with interest from March 29, 2001 at the rate of 7.9 per cent per annum due annually, beginning on the 1st day of April, 2004 and each year thereafter, with both principal and interest payable at UNION STATE BANK. WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from March 29, 2001 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of __ per cent per annum.
