In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- As of OCTOBER 19, 2001, the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$196,000.00 consisting of the amount(s) loaned to the Borrower by the Lender and any Interest capitalized to date.
- 2. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 6.875%, from OCTOBER 19, 2001. The Borrower promises to make monthly payments of principal and interest of U.S. \$1287.58 beginning on the DECEMBER 1, 2001, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.
