AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 29th day of January, 1999, K & R Kids Partnership executed to UNION STATE BANK, WINTERSSET, IOWA a certain note dated on that day for the sum of One Hundred Sixty-five Thousand and no/100----- (165,000.00) DOLLARS payable on the 3rd day of February, A.D., 2002, and at the same time the said K & R Kids Partnership executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 29th day of January A.D., 1999, at 10:52 o'clock A M., in Book 205 of Mortgages, on page 511 and,

Whereas, K & R Kids Partnership is now the owner of the real estate described in said mortgage and,

Whereas, there remains unpaid on the principal of said mortgage the sum of One Hundred Forty-six Thousand Nine Hundred Fifty-five and 18/100----- (\$ 146,955.18) DOLLARS, and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said K & R Kids Partnership hereby agrees to pay on the 26th day of March A.D., 20 02, the principal sum of One Hundred Forty-six Thousand Nine Hundred Fifty-five and 18/100-----

(\$146,955.18) DOLLARS, remaining unpaid on the said note and mortgage, \$1,274.86 is to be paid monthly beginning March 15, 2002 and each month thereafter until February 15, 2005 when the unpaid balance is due, with interest from February 22, 2002 at the rate of 7.5 per cent per annum payable monthly beginning on the 15th day of March, 2002 and each month thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from February 22, 2002 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of _____ per cent per annum.
