AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 3rd day of January, 2001, Larry D. Senhen and Evonne Senhen, Husband and Wife executed to UNION STATE BANK. WINTERSET, IOWA a certain note dated on that day for the sum of Four Thousand Seventy and 58/100-----------(\$4.070.58) DOLLARS, payable on the 15th day of February A.D., 1999, and at the same time the said Larry D. and Evonne Senhen executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 8th day of January A.D., 2001 at 2:30 o'clock P. M., in Book 2001 of Mortgages, on page 70 and,

Whereas, there remains unpaid on the principal of said mortgage the sum of <u>Four Thousand Seventy and</u> 58/100-----(\$4,070.58) DOLLARS, and,

Whereas, the said <u>makers</u> have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said <u>Larry D. and Evonne Senhen</u> hereby agrees to pay on the <u>23rd</u> day of <u>January</u> A.D., <u>2002</u>, the principal sum of <u>Four Thousand Seventy and 58//100-----(\$4,070.58)</u>

DOLLARS, remaining unpaid on the said note and mortgage, \$4,070.58 is to be paid in full on July 23, 2002 when unpaid balance is due with interest from January 23, 2002 at the rate of 12.5 per cent per annum due on maturity, on the 23rd day of July, 2002 and each year thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from January 23, 2002 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of \_\_\_\_\_\_ per cent per annum.
