I, Bruce Eastman , being first duly sworn on oath, depose and state as follows:
1. I am the <u>Son</u> (insert relationship) of <u>Vivian L. Eastman</u> (the "decedent") who died on the <u>23rd</u> day of <u>November</u> , <u>2006</u> , and have an interest in the real estate described below by virtue of the fact that I am (surviving joint tenant with respect to the real estate described below) (a beneficiary of the <u>Vivian L. Eastman Revocable Trust</u> Trust created by agreement dated <u>May 19, 2004</u> .)
2. There will be no estate proceedings instituted on account of the decedent's death. 3. Pursuant to Section 450.22, subsection 3 of the lowa Code, no inheritance tax return is required to be filed in the Estate of <u>Vivian L. Eastman</u> since (i) there is no federal estate tax filing obligation, and (ii) all of the decedent's assets either were held in joint tenancy with right of survivorship solely between the decedent and individuals listed in Section 450.9 of the lowa Code as individuals that are entirely exempt from lowa inheritance tax, or passed by beneficiary designation or pursuant to a trust intended to pass the decedent's property at death or through any other nonprobate transfer solely to individuals listed in Section 450.9 as individuals that are entirely exempt from lowa inheritance tax.
4. The following described real estate was owned by (the undersigned and the decedent as joint tenants with rights of survivorship) (the Vivian L. Eastman Revocable Trust created by agreement dated May 19, 2004) at the time of Vivian L. Eastman is death: Lot 9, Block 18, West Addition to the Town of Winterset, Madison County, Iowa.
