The Northwest Fractional Quarter (¼), the North Half (½) of the Southwest Quarter (¼), the West Half (½) of the Fractional Northwest Quarter (¼) of the Northeast Quarter (¼), and all that part of the East Half (½) of the Fractional Northwest Quarter (¼) of the Northeast Quarter (¼) which lies West and North of North River, ALL in Section Two (2), Township Seventy-six (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, EXCEPT the following described parcels, to-wit:
