The West Half (½) of the Southwest Quarter (¼) of Section Twelve (12), Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, **EXCEPT** that part thereof lying and being North and West of the public highway (commonly known as the Afton Road), **AND EXCEPT** that part thereof that lies within Parcel "D" as shown in Plat of Survey filed in Book 2002, Page 3456 on July 16, 2002, in the Office of the Recorder of Madison County, Iowa; **AND** a tract of land located in the Northwest Quarter (¼) of the Northwest Quarter (¼) of Section Thirteen (13), Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, described as follows, to-wit: Commencing at the Northwest corner of the Northwest Quarter (¼) of the Northwest Quarter (¼) of said Section Thirteen (13) and running thence South 16.81 chains, thence East 2.40 chains, thence North 54 ¾° East, 6.90 chains, thence North 25° West, 1.90 chains to the center of Middle River, thence down said river, 68° East, 8 chains, thence North, 89° East, 5.17 chains to the East line of said 40 acres, thence North 7.90 chains to the North line of said Section Thirteen (13), thence West to the place of beginning.
