ORDINANCE NO. 1911

AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF WEST DES MOINES, IOWA 2009 BY AMENDING TITLE 9 (ZONING), CHAPTER 6 (COMMERCIAL, OFFICE, AND INDUSTRIAL ZONING DISTRICT), SECTION 6 (COMMERCIAL, OFFICE AND INDUSTRIAL USE REGULATIONS), SUBSECTION C (TABLE 6.1 USE MATRIX); DIVISION G (RETAIL TRADE) TO ALLOW SIC 577: MOTORCYCLE DEALERS AND SIC 559: AUTOMOTIVE DEALERS, NOT ELSEWHERE CLASSIFIED AS PERMITTED CONDITIONAL USES IN THE GENERAL INDUSTRIAL (GI) ZONING DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST DES MOINES, IOWA:

Section 1. <u>Amendment.</u> Title 9, Zoning; Chapter 6, Commercial, Office and Industrial Zoning District; Section 6, Commercial, Office and Industrial Use Regulations; Subsection C, Table 6.1 – Use Matrix; Division G (Retail Trade), is hereby amended by inserting the highlighted bolded language as follows:

Section 2. Repealer. All ordinances or parts of ordinances in conflict with the provision of this ordinance are hereby repealed.

Section 3. <u>Savings Clause</u>. If any section, provision, sentences, clause, phrase or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any provision, section, subsection, sentences, clause, phrase or part hereof not adjudged invalid or unconstitutional.

Section 4. <u>Violations and Penalties.</u> Any person who violates the provisions of this Ordinance upon conviction shall be punished as set forth in Section 1-4-1 of the City Code of the City of West Des Moines, Iowa.

Section 5. Other Remedies. In addition to the provisions set out in the Violations and Penalties Section herein, the City may proceed in law or equity against any person, firm or corporation for violation of any section or subsection of this Ordinance.

Section 6. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
