

I am a practicing attorney in Des Moines, Polk County, Iowa, and in that capacity have become well acquainted with the circumstances surrounding the consolidation of Peoples Bank and Trust Company, Cedar Rapids, Iowa, with and into Norwest Bank Marion, National Association, located in Marion, Iowa, effective as of October 1, 1988, and the change in name of Norwest Bank Marion, National Association thereafter to Norwest Bank Cedar Rapids, National Association, with headquarters in Cedar Rapids, Iowa.


