RESTATED ARTICLES OF INCORPORATION
OF
SCRIVNER, INC.

Pursuant to Sec. 496A.61, Code of Iowa, SCRIVNER, INC. does hereby restate its Articles of Incorporation as follows: such restatement to become effective on the date on which the Secretary of State issues the restated certificate of incorporation:

ARTICLE I

Name of Corporation

The name of the corporation is MIDWEST SEALANTS, INC.

ARTICLE II

Duration

This corporation shall have perpetual duration.

ARTICLE III

Purposes and Powers

The corporation shall have unlimited power to engage in and to do any lawful act concerning any or all lawful business for which corporations may be organized under the Iowa Business Corporation Act.

ARTICLE IV

Stock

The aggregate number of shares which the corporation is authorized to issue is One Hundred Thousand (100,000) shares, consisting of a single class, and of a single series. Each share shall have a par value of One Dollar (\$1.00).

ARTICLE V

Registered Office and Agent

The address of the initial registered office of the corporation is RR 1, St. Charles, Madison County, Iowa 50240; and the name of the initial registered agent at such address is: Jerry B. Scrivner.

Directors

The shareholders shall have the pre-emptive right to acquire additional shares of the corporation, either as to treasury shares, or authorized, but unissued, shares of the corporation.

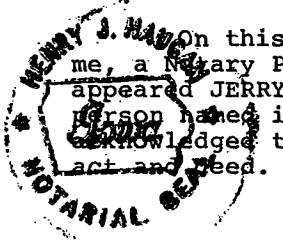
ARTICLE XIV
