AMENDED AND RESTATED ARTICLES OF INCORPORATION OF C & L CONSTRUCTION COMPANY, INC.

Pursuant to the provisions of Iowa Code Section 496A.61, the undersigned corporation adopts the following Amended and Restated Articles of Incorporation:

FIRST: The name of the corporation is C & L Construction Company, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is authorized to pursue is the transaction of any or all lawful business or businesses for which a corporation may be incorporated under Chapter 496A of the Code of Iowa.

FOURTH: The aggregate number of shares which the corporation has authority to issue is One Thousand (1000) shares of capital stock of one class, each share to have a par value of One Hundred Dollars (\$100).

FIFTH: The Amended and Restated Articles of Incorporation correctly set forth the provisions of the Articles of Incorporation as theretofore or thereby amended and supersede the original Articles of Incorporation and all amendments thereto. Said Amended and Restated Articles of Incorporation have been duly adopted as required by law.
