Pursuant to provisions of Iowa Code Section 496A.61, Ritter Insurance, Inc. hereby adopts the following Restated Articles of Incorporation:

ARTICLE I

The name of the corporation is Ritter Insurance, Inc.

ARTICLE II

This corporation is organized under the provisions of Chapter 496A of the Code of Iowa.

ARTICLE II

This corporation has perpetual duration.

ARTICLE III

This corporation has unlimited power to engage in and to do any lawful act concerning any or all lawful businesses for which corporations may be organized under Chapter 496A of the Code of Iowa.

ARTICLE IV

The aggregate number of shares which the corporation has authority to issue is two hundred (200) shares of capital stock of one class, each share to have a par value of One Hundred Dollars (\$100.00).

The restated Articles of Incorporation correctly set forth the provisions of the Articles of Incorporation as heretofore or hereby amended; they have been duly adopted as required by law; and they supersede the original Articles of Incorporation and all amendments thereto.
