The undersigned Incorporator of a corporation organized Fee \$20.00 under the Iowa Business Corporation Act, Chapter 496A, Code of Iowa (1987), does hereby adopt the following Articles of Incorporation for such corporation.

NAME OF THE CORPORATION

The name of the corporation shall be M & J Corporation.

ARTICLE II. **PURPOSES**
