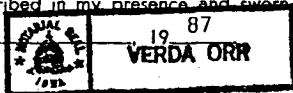

### POWER OF ATTORNEY

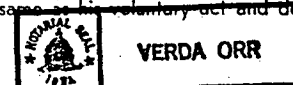
