- Said shares shall be paid and distributed to each of the above named stepchildren and grandchildren and one such share, per stirpes, to the then surviving issue of each then deceased stepchild of mine, provided however, that if any grandchild shall not have attained the age of twenty (20) years, the share or partial share which would otherwise be paid and distributed to such grandchild shall be designated with the name of such grandchild and shall continue to be held as a separate and distinct trust and trust fund.
