

AFFIDAVIT
NOTICE OF MERGER AND NAME CHANGE

I, Christie R. Allen, Corporate Secretary of AgAmerica, FCB, a federally chartered instrumentality and corporation organized and existing under the laws of the United States of America, do hereby, on oath, depose and certify that:

Pursuant to authorities granted in Section 7.12 of the Farm Credit Act of 1971, as amended, the Farm Credit Bank of Omaha and Farm Credit Bank of Spokane (the "Banks"), executed an Agreement and Plan of Consolidation (the "Agreement") dated September 23, 1993, effective as of the commencement of business on April 1, 1994, to consolidate into a new entity and federally chartered instrumentality and body corporate, known as AgAmerica, FCB, the headquarters of which shall be located at W. 601 First Avenue, Spokane, Washington 99220.

Article 1, Section 1.1 of the Agreement provides that:

"On the Effective Date, the Banks shall consolidate into AgAmerica, FCB, the corporate existences of the Banks shall cease, and AgAmerica, FCB shall succeed to all the properties, rights, privileges, powers, franchises, immunities and purposes, and shall succeed and be subject to all the debts, liabilities, obligations, restrictions and duties, of the respective Banks, all without further act or deed."

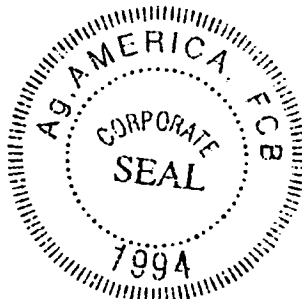
The Agreement was approved by the respective Boards of Directors and voting stockholders of the Banks and by the Farm Credit Administration. The territory served by AgAmerica, FCB is the combined territory of the Banks, namely, all of the states of Alaska, Idaho, Iowa, Montana, Nebraska, Oregon, South Dakota, Washington, and Wyoming. The Farm Credit Administration issued a new charter accordingly, with the effective date being April 1, 1994.

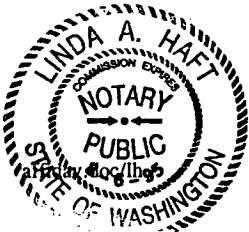
